The Catskill community is highly encouraged to attend the first community workshop, held by the LPC, to learn about the DRI process, the upcoming Open Call for Projects, and to collaborate on input to the Village that will help shape the Strategic Investment Plan and contribute to the revitalization of the Downtown Creek District, which covers a core stretch of Main Street, Catskill Creek, and West Main Street. The Village of Catskill was awarded \$10 million from New York State through the Downtown Revitalization Initiative (DRI) as the NYS Round 8 Capital Region winner. This investment will enable Catskill to develop a Strategic Investment Plan for the Catskill Downtown Creek District and realize key transformative projects that advance the community's vision for downtown revitalization. Projects selected through an Open Call process for DRI funding (June 30 to mid-August 2025) will transform downtown and support a vibrant local economy. All community members will have the opportunity to sponsor project proposals that align with the DRI program goals and community aspirations identified as part of the planning process. To be eligible, a project must lead to economic revitalization through capital construction, begin within two years, and be led by a sponsor with capacity to execute the project and manage a contract with the State on a reimbursement basis.

Natasha Law, Village of Catskill Board of Trustees President said, "Community engagement is a core element of the Downtown Revitalization Initiative, and the Village and LPC are eager to engage
